#### Meeting called to order 11:01am.

Don Lipkin - GC report — Welcomed everyone. Don highlighted that we measure success by whether the athletes have the opportunity to train and compete. We are on the way to returning to pre-pandemic levels but the clubs are down a bit. We have a flux in clubs. Need to start looking at volunteers to take board positions, as will have a few potential vacancies next year. Don asked people to encourage more volunteers.

Addison Otters have moved to New England LSC. We stand at 25 clubs with 2-3 clubs that left during Covid are thinking about returning. The season looks much healthier this year than in the past few years. Short course meets are about 21-23 meets available. Although we were able to hold several meets last year many were TTs style meets. Don highlighted that often people ask why we keep so much in reserve in the financial budget. He explained that Covid taught us that we needed the financial safety net. We were able to weather more unknowns because of the reserve. We did draw down on it during that time period to help clubs financially.

#### Debbie Erickson- Finance report

Net income of \$9,600, we have not been spending the Outreach budget. Annual audit of accepted agreed upon procedures will be conducted this year by Cushak & Company. Adam Hershberg asked about the possible reduction in sanction fees. He highlighted that admission will be down, no program sales, no concessions. Restrictions regarding facilities for meets may result in revenue being reduced. Adam – higher pool fees means less revenue. Debbie said waiving fees means a loss of \$40k to AD Swimming. Don asked that we review the financials following the meets and look at potential shortfall. Debbie encouraged clubs to copy AD on the financials.

Bill Faucett, Registration – The new USA Swimming system for registration is tricky with reporting. They are working through the kinks. He highlighted that we have some clubs rejoining and new clubs going

through the certification process. One of the clubs is in Fulton. They are going through the process. Bill also discussed that the transfer requirement for athletes between clubs has been reduced from 120 days to 60 days from the date of last competition. This allows athletes to affiliate with their new teams sooner.

Andres Paradis, Technical planning delivered by Don Lipkin (report attached) – Host teams for championships for 2023 short course season may be able to access RPI for the 1<sup>st</sup> week of March. Rob Mcleod has spoken with facilities management at RPI and it is looking hopeful that we may be able to get it for at least one weekend.

Caitlin Cho, Athlete Report – They have been trying to get an athlete board started so that all of the athletes in LSC are getting involved. Caitlin stated that are asking each team to provide an athlete rep (10<sup>th</sup>-11<sup>th</sup> grade) as a contact for the club but they are having difficulty getting the coaches to provide the contact. Don implored the clubs to provide that athlete names. She said if they don't get names from the teams the athlete reps will assign them. Attendees spoke up: Carly Antolick is the rep for Starfish, Julia Napoli -Hawks.

Rob Macleod, Governance Committee – Rob explained what the Committee does and what they are working on. He is trying to establish monthly meetings on the 3<sup>rd</sup> Wed every month. Those will be posted on the AD website.

Sean Caron, Safe Sport – He highlighted the need for more teams to obtain Safe Sport recognition. It is easy to obtain the recognition. The new guidelines are in the attached report. Start organizing now because new guidelines will be available in November. He needs each team to provide a Safe Sport Coordinator and each team has to have someone available to contact in the event of a safe sport issue (i.e. bullying, abuse, etc.). If a team has the recognition make sure it is on the team's webpage. 9 clubs in AD currently have the recognition on their webpage. In an effort to push teams to go through the process, Don asked Marco to see if it is worth AD putting it in the LSC bylaws to require teams to identify the POC for Safe Sport to ensure that is completed; it is such an important recognition. Sean agreed to add information to the AD website concerning the MAAP v2 paperwork.

Marco Greico, Vice Chair – He represented AD at the USA Swimming HOD meeting in Colorado Springs. HE highlighted that the next 4-year cycle fees remain the same. See report for specifics. HOD 360 credentials. They are requiring that every meet host have I male and 1 female Meet Marshall Jan. 1<sup>st</sup> 2023. Each sanctioned meet must have a quality control. Meet 360 failed for now.

Meet announcements -1/1/23 – must disclosure medical supervision available. Requirement from USOCP.

JoAnn Faucett, Officials Report – An officials clinic was held at Shen HS and 6 teams attended. She highlighted that it is really important for teams to have more officials. In particular, those teams that host meets. The requirement is to have 2 officials on the team to host a meet in order to obtain a sanction however some teams have been really loose with this requirement. It is expected that there are 2 officials from the host team present during every session of the meet. Discussion surrounding this requirement included the possibility that fines could be imposed if a host team does not meet this requirement for all sessions of a meet.

Rossi Maldonado, Diversity & Inclusion – USA swimming is pushing to implement strategies regarding engagement, education, empowerment but they need more people attending the meetings. Rossi stated that in order for us to function as an LSC we need people to attend and be involved and that includes a lot more athletes being involved. Rossi highlighted a pilot swim lesson program for children with Autism at the JCC. AD has agreed to cover 3 children for the \$90 fee.

Jen Dixon, Swimposium – The event is back on the schedule and details will be coming soon. It will be held at Shen HS the weekend of May  $6^{th}$  &  $7^{th}$ .

General Chair's Report October 16, 2022

Our last BoD/HoD meeting was held on June 4, 2022. I am pleased to say that Adirondack Swimming is continuing our rebound from two and a half tough COVID years as we kick off the Short Course season. Let's break it down by the numbers:

- Our Athletes. We're back up to ~1900 athletes, approaching the pre-COVID high of just under 2200. Compared to a year ago (~850 athletes) and Long Course season earlier this year (~1700), we're on the right trajectory. Most importantly, our athletes are back in the water and will have a full competition season (see below).
- Our Clubs. We stand at 25 clubs, down from our pre-COVID high of 32. We're sad to say goodbye to the Addison Otters as they switch LSC's to New England Swimming next season, but are happy that they are rebuilding after Peter Bicknell's retirement and wish them the best of luck. On the flip side, we have several clubs coming back after a hiatus as well as newly forming.
- Our Competitions. We already have 21 meets approved or bid through the season, and the Tech Planning Committee is working hard to arrange the Silvers and Golds championship meets. While this may not at first blush seem like a huge improvement from last year's numbers, a third of last year's meets were time trials and intrasquad events due to severe facility restrictions.
- Our Finances. We have weathered the worst of our fiscal troubles, in large part thanks to our reserve, which currently stands at just under \$400k. Leveraging our reserve allowed us to provide relief to Clubs and families through fee waivers, additional travel grants and other support while remaining committed to our Outreach activities through individual and community grants. We expect to be nearly cashflow neutral by the end of the 2022-23 fiscal year. Furthermore, the updated Policies and Procedures legislation passed by the HoD in the Spring will help maintain our fiscal rigor and proper controls so that we can deploy the resources of Adirondack Swimming responsibly.

I'll close the report by paraphrasing my closing remarks from June:

Athletes, parents, and coaches: Adirondack Swimming is YOUR organization. The Board represents you, your interests and your financial contributions. We are here so that our Athletes have opportunities to practice, compete and develop their self-confidence and sportsmanship without having to worry about the nitty-gritty of LSC operations. Please continue to stay involved and let us know if you'd like to participate more strategically as a volunteer in our organization.

## AD Fall 2022 Meeting Report Registrar

The 2022 registration season (September 1, 2021 – August 31, 2022) looked closer to normal. AD had 1901 total Athletes and 281 Non-Athlete members, totaling 2182.

New registrations are looking up this season so far.

The new SWIMS 3.0 and OMR (online member registration) have been "challenging" so far. Hopefully the new system gets fixed soon, as we all have had quite a time with it.

Everyone must register themselves, or parents must register their children, directly with USA Swimming. Clubs and LSC's do perform any USA-S registration processes anymore.

Clubs are now more responsible to verify the registrations of their members and keep ahead of their non-athlete members requirements. Every club has at least one new Club Admin who has full access to their club's information and their member's information. Head Coaches and club Registrars also have a good deal of SWIMS access to their club and member information.

The new SWIMS system allows access based on the user's security level.

Parents and Members can see their information only, when logged in to their Dashboard.

This replaces Deck Pass for everyone.

Users with higher security levels have more options available in their Dashboards.

The biggest issue we have had so far is the creation of a user's Login Account. I have information and instructions posted on the AD site on the "USA-S Registration" link. USA Swimming has contracted a third-party vendor (Ping One) to administrate the secure access to their SWIMS and OMR systems. The "account" a user creates is really just a login verification of a valid user. It has nothing to do with the members information in SWIMS. Logins can be completely deleted and recreated without any effect on the member's SWIMS record.

The second largest issue is when someone creates a New SWIMS record when they should have Renewed themselves. This new system is not very good at catching duplicates because of the new randomly generated ID format. We have had thousands of SWIMS records merged. If you were ever a member of USA Swimming in any capacity, you must Renew.

The transfer process has not changed. AD still requires a Transfer Form and \$5 fee for athletes. See FORMS and USA-S Registration pages and fee can be paid to AD by check or PayPal.

The transfer waiting period has been reduced from 120 days to 60 days for all athletes.

Updates will be posted as they become available.

# **Updates from the 2022 USA Swimming Annual Business Meeting and House of Delegates**

#### I. ABM-

- -USA Swimming Membership is up. This year there was an increase of 57,107 premium athletes from the previous year. The 2022 premium athlete registrations (339,305) has surpassed the 2020 registrations of (320,180) and 2021 (282,198). Also in the 2022 year- Outreach memberships increased by 1,352 from the previous year and Flex decreased by -2,418. Adirondack is in line with these numbers as we are seeing the same trend on the premium (year round) athlete registration numbers for our LSC. USA Swimming is very pleased with the direction that athlete registrations are trending in as they begin to reach back to Pre-Covid levels. Non Athlete registration also increased from the previous year by 4,296 for a grand total of 39,416 total non-athletes in 2022. The number of clubs decreased by 17 from the previous year with a 2022 total of 2,699 registered clubs in USA Swimming but the number of new clubs increased by 13 in 2022 from the previous year (84 total new clubs).
- -USA Swimming will suspend the yearly increase in its membership fee at the end of this quad. The BOD approved this initiative at its meeting.
- -Despite the technical issues, SWIMS 3.0 has had a very successful launch. They have seen a record number of registrations when compared to this point in the year other years. Patrick Murphy and his team have worked around the clock to address issues that have come up but HQ is happy with how the launch has gone. They will continue to iron out the issues that come up which can be submitted through creating a ticket with support.
- -Credentials National Committee is being sunsetted. It will no longer exist going forward.

#### II. HOD/Legislation

- -438 Possible Credentials could have been issued for the House of Delegates. Only 326 were issued since there were several LSC's who did not submit the names of their delegates by the July 15th deadline.
- -The House of Delegates working group is still a standing task force and will be receiving the breakdown of the 326 credentials that were issued and how many of those logged on and voted in the meeting. They will be using that feedback to guide proposals related to the composition of the HOD.

#### **Important Legislative Actions related to the LSC**

- -R2 and R3 passed which state that each sanctioned meet has to have at least one male and one female Meet Marshal. The effective date on this is January 1, 2023 so please be cognizant of that for those hosting meets after that date.
- -R15 was withdrawn a few days prior to the HOD Meeting on Saturday as a result of the amount of feedback they received. R15 was proposed by the Safesport committee due to a requirement from the U.S Center for Safesport. This legislation dealt with Meet 360 and had the purpose that all meet sanctions at the LSC Level follow the approved quality control system that has been approved by the center and was outlined in the Meet360 deadline. This was going to include publishing a list of volunteers prior to the meet and also publishing a finalized one after the meet. This legislation is a requirement from the U.S Center for Safesport so it will reappear next year so that we as an NGB are compliant. The Safesport Committee will be regrouping and working on a new proposal that incorporates some of the feedback they have received.
- -R16 passed which requires meet announcements to include the medical supervision available to athletes participating in the meet. The effective date on this is January 1, 2023. So those hosting a meet after that date please make sure you include this in your meet announcements.
- -R17 and R18 dealt with the 120 day rule. The proposal was to reduce the 120 day rule to 30 days. It passed in an amended version that set the rule to 60 days. The effective date of this legislation is immediately so that updated rule is now in effect.
- -R25 passed which requires all LSC House of Delegates to be members of USA Swimming. The effective date of this is January 1, 2023 and will be reflected in the next Bylaws update.
- -HK2 passed which had the purpose of removing the use of the term "Junior Olympic". This is effective immediately. This was a directive from the USOPC as the Junior Olympic term is property of the USOPC, not USA Swimming.
- -Resolution 1 passed which set out that the seasonal membership fee will be increased from \$30 to \$40 effective for the 2024 membership year.
- R5, R7 (Withdrawn), R9 (Withdrawn), R11, R12, R13, R14, R15(Withdrawn) were all defeated. The remainder of the legislation was adopted.

#### SafeSport Club Recognition

The process for becoming a Safe Sport Recognized Club (or renewing Recognition) is changing ... details will be announced in November. I would advise clubs to continue with the Safe Sport education, training, and policy actions as I believe these are NOT changing ... just the process to apply will change.

#### Minor Athlete Abuse Prevention Policy v2 (MAAPP2)

MAAPP 2 has been officially adopted as of 9/1/21 and rolled out across USA Swimming. There is an extremely helpful resource site for MAAPP 2 here ->

#### Minor Athlete Abuse Prevention Policy

This site contains MAAPP 2 definitions, policies, FAQs, and details about being MAAPP 2 compliant. Sample forms, language for meet announcements and Meet/Coach's Meetings, and travel permissions forms are all available at this site. There is also a wealth of explanatory video content.

The relevant Meet Announcement language has been in our meet announcements for this year - thank you Bill!

All AD teams should have a certification of compliance with MAAPP 2. As a reminder, I would also like to be notified of club compliance (scaron@nycap.rr.com). There is a sample club compliance document here -> Acknowledgement of Policy

To be in full compliance, the Minor Athlete Abuse Prevention Policy must be reviewed and agreed to in writing by all athletes, parents/legal guardians, coaches and other non-athlete members of member clubs on an annual basis with such written agreement to be retained by the club or LSC, as applicable. Note that this can be managed electronically. Please check out the videos and FAQs on the site above for info about who needs to complete a form - for example for younger athletes. ## AD Fall 2022 Meeting Report Sanction and Times

2021-2022 Meet season produced \$26,500 income for AD in Bid/Travel Fund Fees.

Just over half of pre pandemic totals.

2018-2019 total \$50,000 2019-2020 total \$34,000 2020-2021 total \$0 (AD chose not to collect fees)

Bids are coming in and things are looking more normal this season. Still seeing some issues with pools not yet allowing AD clubs in for meets.

Based on emails I receive, clubs are looking for meets to attend, so get bids in as soon as possible and get information posted as early as possible.

Be sure to use the most current template for announcements. Several changes were made in the last 2 seasons and I expect a few new ones this season.

The new SWIMS 3.0 has caused a number of issues with times, times loading, times recons and meet recons, to mention a few. It's going to take a while to sort all of this out. I'll do my best to keep everyone updated.

- Background Check: New USA-S Login, highlight Education, Course Catalog, Background Check, new members \$38, renewal every 2 years \$18.
- 3) APT (Athlete Protection Training): New USA-S Login, highlight Education, Course Catalog, APT, new official must take the entire course, recertifying officials take the annual recertification condensed version. You can recert your APT up to 3 months before the expiration date.
- 4) Official Clinics: 1<sup>st</sup> Official's Clinic held in Potsdam, Sat Sept 17<sup>th</sup> @ SUNY Potsdam, 4 attendees, one from the Waves, three from the TRIBS. 2<sup>nd</sup> Official's Clinic held in Clifton Park, Sat Oct 15<sup>th</sup> @ Shenendehowa Aquatic Center.
