Reports

Treasurer - Alison Vitullo

- Taxes were filed on time.
- Registration variance due to more swimmers than budgeted. Revenue offset by equal expense.
- Zone team was large, so both revenue and expense above budget.
- Payables are up to date.
- 2014 audit done and submitted to USA swimming.
- Bank balances: moved \$50K to new strategic reserve.
- Adirondack had a positive net income versus an expected slight loss.
- Motion: "to approve report". Motion Passed

Outreach Chair – Carolyn Manor

- 1 LC grant given and 1 pending.
- Sep 12 potential Outreach Clinic date.
- EZ outreach clinic: Steven Yu, Belen Marriage and coach Rossi Maldonado will attend.
- Motion: "to pass report". Report approved.

Registration/Membership Chair – Ann Korzun

- 2015 YTD Statistics: 2176 year round athletes, 123 seasonal athletes, 312 non-athletes and 31 clubs.
- There are 7 new club registrars. There will be a training workshop in conjunction with the Fall HOD mtg.
- Swimmers can now register without proof of age but they are given a "restricted membership" and can only swim open/senior events until proof of age is provided.
- 24% of coaches are currently invalid; 55% will be invalid by 5/31/15

- Background check is now the same for everyone; \$36.50 for new and \$18 for renewal.
- APT now good for 2 years. It can be taken anytime during the year and the expiration date will be Dec 31, 2 years later.
- For coaches instead of lifeguard can now do STSC in-water skills tests.
- USA Swimming has increased their 2016 year-round membership fees by \$2. A motion was made and passed to keep AD registration fees the same as 2015. Therefore, USA-S year-round membership will be \$70 in 2016.
- Working on doing electronic payments for registration.
- Motion: "to accept report". Approved

Age Group Chair - Jenn Nelson

- 59 out of over 80 applicants to zones. Largest number of teams represented.

Safety Chair – Michele Boxley

- Sent in report to JoAnn Faucett
- 2 incidents; one involving a dislocated shoulder;

Senior Vice Chair - Steve Hall

- New Senior meets: Senior Zones champs and Futures Champion (slower than jr nationals and faster than Speedos).
- Eastern Senior Zones and Futures Champions meets have been added to list of meets for reimbursement. An athlete can only be reimbursed for one meet. Teams can also petition for reimbursement for other national type level meets.
- Motion: "To accept report". Motion passed.

Coaches Rep - Jenn Dixon

• Jeff Maxwell elected coach of the year. Will get \$300 for training.

Records Top 10 Chair - Jenn Dixon

- All records have been updated. Pls let Jenn know if anything is missing.
- Motion: "To accept report". Motion passed.

Sanction/Times Chair - Bill Faucett

- 1 new SC meet (Dolfins Fall Challenge), lost 1 meet (Foothills meet)
- \$441 higher in meet fees for SC than last year.
- Important for teams to remember to use new meet template.....certain statements are mandated by USA Swimming and/or Adirondack!!!
- Report passed

Administrative Vice Chair - Sean Caron

- Leap 1 certification renewal in process. Everything submitted on time before May 1.
- Some changes to by-laws had to be made as a result of USA Swimming annual mtg
 - No longer board of review at LSC level
 - An LSC employee cannot be a voting member
 - Must state who is liaison in charge of interacting with athlete members (senior vice chair)
 - o All board members have to sign Conflict of Interest statement.
- LEAP 2 is next step. Have all information but have to wait 6 months to submit.
- Motion: "To accept report". Motion passed.

General Chair - JoAnn Faucett get email report.

- LSC athlete membership dues are due Aug 15. At \$0.25/athlete, AD's fee is \$587.75

- Safe Sport convention in Denver in June. JoAnn will attend.
- Deck changing not permitted. If officials see anything they should approach the coach.
- USA Swimming wants more athletes to do the online safe sport training.
- Cannot take picture behind blocks.
- Motion: "To accept report". Motion passed

Tech Planning Chair – Jerry Adams

- Silvers and Golds: Changes to make meets more manageable. Too dependent on RPI. Expensive and limited availability. Bleachers too crowded.
- Split Silvers in two, held at separate pools same weekend. Change to blue and yellow qualifier meet. No team scoring.
- Gold cuts tighten
- Motion" to change championship meet format to above". All in favor. Passed.
- LC Championship meet fear; we can't run a good meet that is over-subscribed.
 - Need controls to limit numbers.

- Motion: "swim 11-12 200 timed finals during afternoon." Approved
- Motion: "Limit relays to 3 per team per event. If oversubscribed meet director and meet referee will limit relays even further." Motion approved.
- Motion: "To accept report". Motion passed.

Senior Athlete Rep – Julia Samson from Steve

- Still working on Senior Training trip for April 2016.
- Motion: "To accept report". Motion passed.

Junior Athlete Rep – Joey Homan

Presented check from coin drive. \$179 to USA Swimming foundation.
