Adirondack Swimming Requires Legal ID with all Initial Registrations and/or Incoming (from another LSC) Transfers. If the athlete is transferring to AD from another LSC, a copy of the athlete's Legal ID (Birth Certificate, Passport, Government Issued Photo ID or Baptismal Certificate) MUST be included with the transfer.

NOTE ON PRIVATE SCHOOL OR COLLEGE TRANSFERS

USA Swimming Rules allow the waiver of the 60 day (rule 203.3), for any athlete transferring from his/her Age Group Club to his/her College or Private School Club, at the beginning of the school's season and then back to his/her Age Group Club after the school's season is over. This waiver is granted for a Single Transfer off the Age Group Club and a Single Transfer Back to the Age Group Club in any one school year. Any additional transfers are subject to the 60 Day Unattached waiting period.
