Adirondack Swimming charges a fee of \$5.00 for the processing of Athlete Transfers.

After the AD LSC Registrar completes the transfer in SWIMS, USA Swimming will notify the old club that the transfer has occurred. The old club has the responsibility to notify the AD LSC Registrar, within 60 days, if the old club has obtained a judgment in accordance with USA Swimming Rules and Regulations 203.6. If there is a court judgment, the swimmer must swim Unattached until such judgment has been satisfied.

INSTRUCTIONS

This form may be filled in using the Adobe Acrobat "Fill-in" feature (requires Acrobat Reader or Adobe Acrobat, 9 or higher) Use the "PRINT" and "SAVE AS" buttons to print copies to mail and/or to save a filled in copy for your records.

Adirondack Swimming Requires Legal ID with all Initial Registrations and/or Incoming (from another LSC) Transfers.

If the athlete is transferring to AD from another LSC, a copy of the athlete's Legal ID (Birth Certificate, Passport, Government Issued Photo ID or Baptismal Certificate) MUST be included with the transfer.

If the athlete's USA Swimming Registration is CURRENT, This Form, Legal ID (if required) and the \$5.00 transfer fee (check payable to "Adirondack Swimming") may be sent directly to the AD LSC Registrar by the athlete's parent or guardian or may be processed through your club registrar. Check with your club registrar for club policies or requirements.

If the athlete's USA Swimming Registration is EXPIRED, This Form, Legal ID (if required) and the \$5.00 fee MUST be processed through your new club's registrar and included with the athlete's USA Swimming registration.

NOTE ON PRIVATE SCHOOL OR COLLEGE TRANSFERS

USA Swimming Rules allow the waiver of the 120 day (rule 203.3), for any athlete transferring from his/her Age Group Club to his/her College or Private School Club, at the beginning of the school's season and then back to his/her Age Group Club after the school's season is over. This waiver is granted for a Single Transfer off the Age Group Club and a Single Transfer Back to the Age Group Club in any one school year. Any additional transfers are subject to the 120 Day Unattached waiting period.
