Instructions for Unattached Athlete Registration

Adirondack Swimming accepts this form directly from athletes only if they are Unattached with no club affiliation. If you are affiliated with a club, your registration must be submitted through your Club Registrar.

A copy of a birth certificate (or passport, or government issued ID) is required for athletes who were not previously USA-Swimming registered within the Adirondack LSC. This includes NEW swimmers, and TRANSFERS from outside Adirondack.

A transfer form and additional \$5 fee are required for athletes who were registered within the past 2 years to a club other than unattached. (www.adirondackswimming.org under the Forms tab)

There are no refunds once a registration has been entered to the USA Swimming database.

General Instructions:

Name – must be the legal name as it appears on your Birth Certificate. (Preferred name is where you can use a nickname.)

All information is required except Disability and Ethnicity are OPTIONAL.

NEW Athletes are those that have NEVER been registered with USA Swimming in any capacity.

RENEW Athletes are those that have been USA Swimming registered in any capacity in the past.

USA Swimming Insurance is in effect at practice and meets only if the athlete is under the direct supervision of a currently registered and properly certified USA Swimming Coach. If an unattached athlete plans to attend a meet, he/she MUST make arrangements with an attending coach to assume supervisory responsibility.
