ADIRONDACK SWIMMING OBSERVED MEETS

Observed Meets are those meets which are not governed by USA Swimming Technical Rules, where a request for Observation has been made in advance with the Sanction/Times Chair.

High School invitational and championship meets can be Observed.

High School dual meets can Not be Observed.

ALL Requests for Observation MUST be made at least 10 days in advance of the meet.

Requests for Observation require the approval of the LSC Sanction/Times Chair.

Form A is used for non season culminating meets, such as invitationals Form B is used for season culminating meets, such as sectionals or states Form C is used by swimmers to request their times loaded to SWIMS

Hosts, be certain to use the current Adirondack Form A or B from the AD Web Site.

AD Forms A & B are provided in PDF Fill-in Format, with Print and Save As options. Fill in, Save As (be sure use meet name) and email to the Sanction/Times Chair.

Note: Form A also requires meet information be included, such as an announcement or

invitation which states the meet purpose.

Swimmers, be certain to use the current Adirondack Form C from the AD Web Site.

Note: Form C is designed for requests of multiple swimmers from the same high school team

to use. DO NOT ENTER NICKNAMES ... Legal Names Only.

Coaches, DO NOT SEND LISTS OF SWIMMERS ID's ... Form C is the only format accepted.

Adirondack Swimming Does NOT Recognize any other method or form for request for times.

USA Swimming SWIMS System matches swimmers on their full LEGAL NAME and DATE OF

BIRTH, as they appear on the swimmer's birth certificate, and then confirms with their NEW ID.

USA Swimming ID's were all updated 9/1/2022, old ID's are no longer valid.

Form C must be submitted to the Meet Director, **BEFORE THE END OF THE MEET**

REQUESTS ARE NOT ACCEPTED AFTER THE MEET IS OVER

Be sure to submit your request on time.

THE SWIMMER MUST BE A USA SWIMMING REGISTERED ATHLETE, ON THE DATE(S) OF THE MEET, TO HAVE THEIR TIMES LOADED TO SWIMS.

After the meet, the AD Sanction/Times Chair will update the meet file to contain the correct SWIMS data for each swimmer who made a written request using Form C and load the result times for those individuals to SWIMS. NO RELAY TIMES WILL BE AUTOMATICALLY LOADED TO SWIMS. In order for a relay to be legal, all 4 members must be current members of the same USA Swimming Club. In addition, LEGAL SPLITS AND RELAY LEAD OFF SPLITS ARE ALSO NOT AUTOMATICALLY LOADED.

If you have made a written request for times load ON TIME and you have a legal split or relay leadoff split which is a BEST TIME for you in the current season, you must contact the AD Sanction/Times Chair to request that specific split time loaded to SWIMS. Requests for times loads to SWIMS must be made within 30 days of the end of the meet. USA Swimming does NOT want us loading times for meets, months after the meets are over.

The Adirondack Sanction/Times Chair may ONLY load times from Observed Meets which took place in Adirondack Geographical Boundaries and were issued Observations by AD.
